AGREED TEMPORARY RESTRAINING ORDER

This matter coming to be heard upon the Emergency Motion of Navy Pier, Inc. for a temporary restraining order, the Court having reviewed Plaintiff's Complaint and Petition for Injunctive Relief, Motion, Memorandum of Law and supporting affidavit, the Court being otherwise fully advised in the premises, and the Parties having agreed to the terms of this Order:

NOW, THEREFORE, IT IS ORDERED:

- 1. The Defendant International Brotherhood of Teamsters Local 727 and all the members of Local 727, and each of its officers, agents, successors, servants, and employees, and all persons acting by, with, through or under or in concert with them, shall forthwith cease and desist from:
 - (a) Physically, through the use of their own bodies, vehicles, or other items, blocking any portion of Grand Avenue, Illinois Street, or Streeter Drive in a manner that impedes or prevents access to Navy Pier.
 - (b) Parking any vehicle in a No Parking zone on Grand Avenue, Illinois Street, Streeter Drive, or any private driveway or roadway at Navy Pier or the Headlands under the control of Plaintiff, unless directed by the Chicago Police Departments.

- (c) Picketers are to remain on the perimeter of the streets or entrances; provided, however, that the picketers may cross the streets at normal, uninterrupted speed so long as ingress and egress is not physically blocked or delayed by picketers, and so long as picketers shall not place themselves or objects in front of vehicles entering or leaving Navy Pier.
- (d) Endangering public safety by physically delaying or blocking traffic on the streets and entrances to Navy Pier and the corresponding thoroughfares.
- (e) Nothing in this paragraph shall be deemed to prohibit lawful picketing or otherwise restrict any person protected by the National Labor Relations Act, Illinois Anti-Injunction Act or the First Amendment of the United States Constitution from exercising their rights to the same extent as any other person in the City of Chicago.
- 2. In order to notify members of Defendant Local 727 of this Order and to ensure their compliance with this Order, by no later than 5:00 p.m. May 26, 2017, Local 727 shall post a link to a .pdf copy of this Order on its website, and post a link to this Order on its Twitter Feed and/or on any other social media account maintained by Local 727 while this order remains in effect.
- 3. This temporary restraining order shall become effective immediately upon the filing and approval by this Court of a bond in the sum of \$10,000 with good and sufficient security conditioned upon the payment by Plaintiff of all damages, if any, which may be suffered by the Defendants by reason of the wrongful issuing of this injunction and of the entering of this order.

It is further ordered, and the parties are hereby notified, that a hearing shall be held on Plaintiff's motion for a preliminary injunction on June 8, 2017 at 2:00 p.m. in courtroom 2502.

Should the parties mutually agree that no hearing is necessary, they may notify Chambers and request that the Court enter an agreed order striking the hearing date.
