Mr. Franklin and Ms. Bennett:


Instead of honoring your employee's democratic vote in selecting Teamsters Local 727 as its representative, Keurig Dr Pepper has disgustingly fought employee's free choice at every turn. I am pleased to inform you that justice was again on the Union's side and certification of Teamsters Local 727 for all full-time and regular part-time account managers and sales services representatives in Northlake was upheld by the NLRB yesterday in case 13-CA- 247183. Please know that the Union continues to stand strong despite your anti-union tactics and shameful behavior. Now, as they say, Keurig Dr Pepper must face the music and face the consequences of its numerous unfair labor practices and refusal to bargain with 727.

Accordingly, please accept this letter as the Union's continued demand that the Company fulfill its legal obligations and begin negotiations with the Union. As made clear in the Union's numerous communications to you, the Union and its committee remain ready and available to begin negotiations immediately. The Union further propose bargaining at the Union offices in Park Ridge.

Additionally, the Union would like to remind you that the information request sent to you on August 7, 2019 remains outstanding and unsatisfied.
